## World Cups Youth

Participating teams are asking for acceptance of goalkeepers who are one year older than the age group of the World Cup tournament. After some discussion TC approves this wish since more countries have this also in their own rules.
This should be put in the new Conditions for WCS Youth also.
Borrowing a goalkeeper from another club or combined teams participating is not allowed now. We can discuss this issue when it comes up.

Teams from Finland have not yet accepted the invitations, there is some time left. However, there will be no teams from Finland in the World Cups Girls Y15 and Y17.

Question of Egil Larsen: do we need FIB referees in the World Cups Youth because these are FIB tournaments?
Answer: For the moment no, local referees can be used. The costs for organizers would be too high. In the future, RRC, together with Secretary-General, can discuss assigning FIB referees to World Cups. Where possible the financial burden for organizers should be minimized.
We put this also in the new Conditions for WCS Youth, so organizers know what to expect.
Executive Committee has decided (8 August 2023) that World Cups need minimum 6 participating teams, representing 3 nations.
If not enough countries are represented, and an organizer of World Cup Youth wants to keep the name "World Cup" for the tournament, organizer must write an exemption request to FIB Secretary-General.
Kjell Anderstedt is in contact with the current organizers and will inform them.

## World Championships

Executive Committee has decided (8 August 2023) that World Championships need minimum 4 participating national teams.
If not enough countries are represented, and an organizer of World Championships wants to keep the name "World Championships" for the tournament, organizer must write an exemption request to FIB Secretary-General.

A World Championship tournament is assigned and invitations will be sent to all member associations, the organizer cannot be blamed for not enough nations participating. In the current situation, we cannot be too strict with this minimum number of teams rule, this is contra productive for organizers, sponsors, teams etc.
